Outline of Measure 2 Community Recreation Areas

CLÁR (Ceantair Laga Árd-Riachtanais) is a targeted investment programme for rural areas that aims to provide funding for small infrastructural projects in areas that experience disadvantage. The aim of CLÁR is to support the sustainable development of identified CLÁR areas with the aim of attracting people to live and work there. The funding works in conjunction with local/Agency and other Departmental funding programmes and on the basis of locally identified priorities.

In the context of the impact of COVID-19 on communities, CLÁR 2020 will consider support for the enhancement of existing and/or the development of new accessible Community Recreation Areas where people can socialise outdoors in safe community spaces.

Types of Intervention

The measure will support a variety of **capital** interventions provided that they contribute to the enhancement of existing and/or the development of new, accessible Community Recreation areas where people can socialise outdoors in safe community spaces. The examples below provide an indication of the types of interventions that may be supported, but is <u>not exhaustive</u>:

- Covered Seating and Picnic Benches
- Covered BBQ Areas
- Public Toilets and Bins
- Car and Bike Parking
- Outdoor Electricity Connection
- Outdoor Cinema Screen, Bandstand, Amphitheatre, Blackboard
- Outdoor Drinking Water Fountain
- Exercise Class Space
- Handball Alley Renovation
- Associated Landscaping and Path Widening

The application form must clearly outline the need and rationale for the interventions put forward. All projects must display and encourage abidance by Leave no Trace principles. The cost of appropriate signage may be included in the overall project costings.

Eligible Applicants

Community Groups, Local Development Companies, Local Authorities.

Eligible Costs

Applications should detail all of the costs associated with the proposed project and only items of a capital nature that are integral to the project should be included. All administration costs/professional fees associated with the proposed project should be kept to a minimum and such costs will be eligible up to a maximum of 10% of the overall project costs.

Assessment Criteria:

10 Projects across Measures 1 & 2 will be prioritised by the Council for submission to the Department based on the following criteria:

- Application made by eligible Group/Organisation located in a CLÁR area
- Clear evidence of need / impact outlined in application form, i.e.
 - Need and rationale for project
 - Social, economic and environmental impact and benefit of community recreation area works / project
- Quality and clarity of supporting documentation, i.e.
 - evidence that all necessary permissions are in place
 - evidence that match funding is in place where relevant
 - evidence where applicable that ownership/lease is in place or express permission of the landowner on file for any project involving lighting of fires
 - full estimated costs including administration/professional fees (procurement not required at this point)
- Clear social benefit, i.e. facility open to the public without appointment
- Relevance to the LECP and other local or regional developmental plans or policies

The Departmental assessment of applications for recommendation to the Minister will take into account a number of factors including the indicated order of priority; the range, mix, quality and impact of proposed projects; previous funding provided; and other relevant considerations.

Project Delivery

It is expected that the local authority will take a lead role in the delivery of many of the projects approved by the Department. However, LDC's may, with the agreement of the LA and the relevant community applicants, be permitted to take on the project delivery phase. In such cases the Department will enter into a contract directly with the LDC and not the LA.

Grant Payment Arrangements

Payment arrangements: in arrears of 50% on completion of at least 50% of the project, and 50% when the project has been fully completed.

Drawdown requests for payment should only be submitted to the Department of Rural & Community Development by the LA/LDC when the LA/LDC has itself incurred the expense. It is not acceptable that a drawdown request be submitted to the Department if invoices etc. submitted to the LA/LDC by community groups/contractors remain unpaid.
