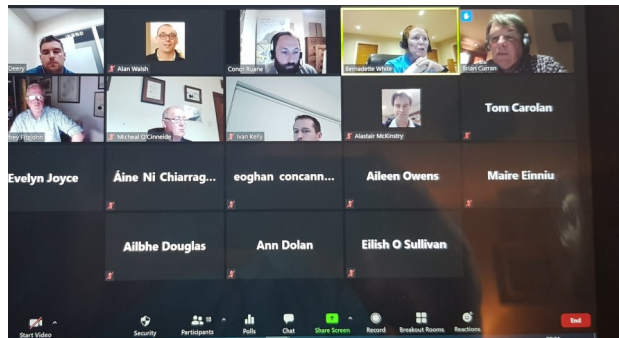

Cashla PAA Online meetings

The first online PAA meeting in the Western Region was held via Zoom on Sept 28th. The meeting focused on the Cashla Catchment located in south Connemara Co. Galway and was well attended by important stakeholders in the catchment. A presentation on community engagement was given by Conor Ruane (Community Water Officer) while Francis Deery (Catchment Scientist) gave an overview of the Catchment Assessment Team's work to date and work plan for the area.

Zoom has been a revelation during Covid-19 restrictions and was adopted early by LAWPRO to deliver Community Information Meetings in the Priority Areas for Action. It is proving an effective method for delivering information about water quality and LAWPRO work plans to the local community and stakeholders.

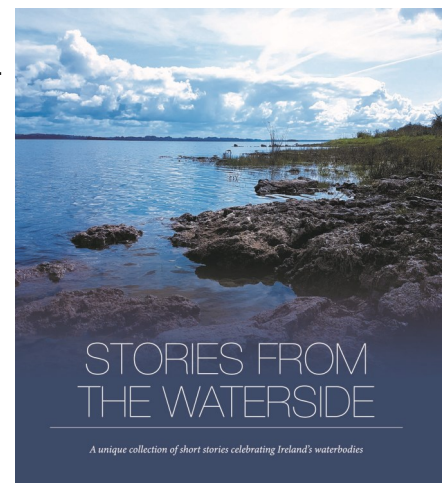


Stories from the waterside

Stories from the waterside is a unique collection of short stories celebrating people's connections with Ireland's waterbodies. It was published to mark Water Heritage Day and National Heritage Week 2020. The stories included in the book were shortlisted from 470 stories entered in a writing competition of the same name held in April and May, during Covid-19 Lockdown. The competition was organised by the Local Authority Waters Programme (LAWPRO), in partnership with The Heritage Council, Inland Fisheries Ireland, Waterways Ireland and The Heritage Officers Programme.

The initiative and publication captured the spirit of volunteering and community engagement in water quality management and also includes some top tips from LAWPRO and the EPA for communities to take action to protect water, biodiversity and our climate.

The EU Water Framework Directive (WFD)

The WFD was the first directive to mandate participation by stakeholders and communities in developing and implementing public policies.

River Basin Management Plans (RBMPs)

The WFD requires good water status for all rivers, lakes, estuaries, groundwater and coastal waters. This is to be achieved through RBMPs and programmes of measures, developed and implemented in three six-year cycles up to 2027.

Public consultations on the 3rd Cycle RBMP are due to commence in January 2021 for a period of six months.

A healthy catchment provides good quality drinking water and ensures that plants, animals, fish and insects will survive and flourish. People are naturally drawn to locations with good water quality, whether for recreational or sporting activities. For those reasons, it is in our interests to protect and enhance our local catchments.

Good water quality is essential for human health, for wildlife and for vibrant communities.

EcoEye Filming on Lough Carra

The RTE Eco Eye team were filming a programme on Lough Carra during September, the programme will be aired on RTE in early 2021. Lough Carra is the largest marl lake in Ireland and is part of the Great Western Lakes complex. It covers 1,560 hectares and is joined to Lough Mask by the Keel River. It has many islands and a ragged shoreline with a plethora of bays and promontories, all on a bedrock of limestone.
