# About Galway County PPN Linkage Groups: What they are, how they work and How you can get involved





### What is a Linkage Group:

A <u>Linkage Group</u> is a collection of PPN member groups/organisations who have an interest in the work of a given external committee. The Galway County PPN also refers to such groups as 'Working Groups' and 'Forums'.

#### **Role of Linkage Groups:**

1. PPN representatives on local policy committees feedback to their Groups and facilitate the two way flow of information between policy makers and the community.



- 2. Linkage Group members meet to discuss and debate policy and help inform PPN reps and support them in forming a position on policy issues that represents the community voice.
- 3. The Group also nominate, elect and otherwise support PPN reps on these external committees.

#### **Joining Linkage Groups:**

- 1. Any PPN member/individual can join any Linkage Group/Working Group/Forum at any time. Some Groups may be more active than others.



#### **How Linkage Groups work:**

- 1. There is one Linkage Group created for each external committee that has seats allocated to Galway County PPN reps.
- 2. New Linkage Groups are established by the Secretariat on an issue basis or as requested.
- 3. Linkage Groups report to the wider PPN membership at the Plenary meetings.
- 4. A Linkage Group lasts the lifetime of the committee it is aligned to, or for the purpose it was formed for (for example a consultation process).
- 5. Until a facilitator is appointed from its membership, each group is facilitated by the PPN workers, to organize meetings, communications and the general work of the Linkage Group.
