#### **WELCOME & BUSINESS MATTERS**

Vincent Lyons welcomed everyone to Galway County PPN's first Plenary since 2020.

Charlotte May presented on the work and role of the PPN as a refresher for Members.

Lorraine Lally from Epilepsy Ireland noted that this has all been heard before and questioned the impact the PPN was having. She noted that she had been a part of the 2007 Working Group on Active Citizenship and that not much had changed since then. She remarked that the Pillar system was not working and that marginalised groups were not being accessed and supported. She questioned whether the PPN was aware if their emails were getting to people. The Workplan was also queried.

Vincent Lyons commented that the Galway Co PPN reach out to groups and operate an Opt in policy whereby groups are invited to engage with the PPN.

Charlotte explained that the PPN does also reach out to groups and that the emails sent out were monitored and that people were welcome to suggest amendments to the Workplan and help create it. To increase participation a hybrid model for the PPN would be adopted going forward, meaning that one Plenary will be held in person and one will be held on online, to increase participation.

Votes were taken on changing the PPN Constitution, adopting the Workplan and Budget 2022, and ratifying newly elected PPN Reps.

Charlotte explained the suggested amendment to the Galway County PPN Constitution of 2018:

- Reason: Current Constitution requires 10% of members in attendance to make decisions (PPN Handbook suggests 15%). For the Galway County PPN this means that at each Plenary, over 100 Member Groups would need to be in attendance. Achiveing this much participation was rarely achieved.
- DRCD issued a circular to update this rule to allow for a simple majority required to pass a vote of those attending.
- Background: Many PPNs were not reaching required numbers at Plenary meetings. This mean that decisions could not be legitimately made by the Plenary.

Next, the Workplan and Budget 2022 was discussed. Lisa Fenwick from DFI asked that the following changes be made: Under **Objective 1** in relation to the **Galway Disability Forum** in the 'Who can help?' Box – to amend this to include **SPC Reps and LCDC Reps** to ensure that any issues that may arise that are related to the work of the County Council e.g. Housing or Planning get fed into the relevant SPC and/or to the LCDC?

Lisa Fenwick also mentioned that accessibility of information is crucial for the Galway Deaf Club and NCBI Advocacy Local Area Network to be able to participate in the work of the Forum and the PPN.

Charlotte agreed to make these changes and to look into making the PPN info available in Irish Sign Language.

Áine Bhreathnach from Coiste Forbartha Corr na Móna said that all documents were sent out too late, only a few days before the meeting. This left not enough time to process them.

Charlotte said that next time documents would be sent out sooner but that all documents have been publicly available, online since the beginning or the year under the 'Resources' section of the website. She also noted that the Workplan had not changed significantly compared to the previous year as the work of the PPN is consistent between the years and projects 'roll' into one year from the last.

Next, Mark Green from An Tasice queried what the difference in the 2022 Budget was compared to last years' Budget. Charlotte explained that the main difference was the price cap placed on events such as the Cathaoirleach Awards which the DRCD has set at €4000. Otherwise, there was slightly more funding place on IT/web- based services to accommodate the increased use of online platforms such as Zoom, since the Pandemic. Otherwise, the Budget allocation had not significantly changed from the 2021 Budget.

A Vote took place.

The Workplan and Budget 2022 was approved by Plenary & adopted by PPN.

  - Fiona highlighted the Resource Pack the LGBTQI Interagency Support Group had made at that this would form the basis of training being rolled out in October.
- Anne Graham (Community Finance Ireland), 'Financing for Community led organisations'
  - Anne explained how Community Finance Ireland support community groups through flexible funding support options (see Presentation Slide 66 onwards).
- Cian Strolla (Cipher Digital Developments Ltd), 'LocalHub Connecting communities with localised information'
  - Cian presented on his new app aimed to bring communities together in a concentrated manner, with targeted, local information directly to people's phones about what is happening locally (see Presentation Slide 81 onwards).

#### **Suggested Amendment to PPN Constitution:**

#### **Attending the Plenary Meetings**

The main decision-making body of the PPN is the Plenary (i.e. all the independent Member Groups of the PPN) which should, unless in exceptional circumstances, meet at least once a year to review how the PPN is working and to set the work agenda for the coming period.

The main role of the Plenary is to direct the operations of the PPN, to set overall PPN policy and procedures and to agree the annual Workplan and budget. The elected Secretariat is responsible for the administration of the PPN between Plenary meetings.

Subsets of the PPN such as Municipal District PPNs and Linkage / Thematic Groups also inform the process.

Registration for meetings is mandatory and includes registration by members, Secretariat members and staff.

A Plenary Meeting shall be deemed a valid meeting if at least 15 per cent of the Member Organisations are represented and also if at least four of those present are members of the Secretariat. There must also be an automatic and guaranteed 21 days' notice of the meeting.

If a quorum is not available, those present may elect to proceed with either of the following:

#### **Option A**

- The meeting should be postponed and rescheduled for a more suitable date, no later than one calendar month after the date of the original meeting.
- In the event that a quorum is not present at the rescheduled meeting, and provided that those
  in attendance consist of a simple majority (that is, half plus one) of all groups registered to

- attend the meeting, the number of participants present will be deemed to be the quorum and the meeting will be validly held.
- No objections to proceedings, including resolutions, ratifications and decisions, of the
  rescheduled meeting shall be permitted on the basis that there was no valid quorum in
  attendance at the originally scheduled meeting.

#### **Option B**

Determine that the current attendance at the plenary is sufficient for the plenary to proceed.
 Decisions made at this plenary will be validly passed by a simple majority (that is, half plus one) of those in attendance.

In any event, if over 50% of the Secretariat Members' terms have expired by the date of the holding of the Plenary meeting, or the rescheduled Plenary meeting, whichever shall apply, the requirement that the quorum include four Secretariat Members will cease to apply.
