BUSINESS MATTERS

➤ Reflection on 10 Years of PPN - Jarlath Canney, Dan Dowling, Vincent Lyons, PPN.

The three Secretariat members who have volunteered on the Secretariat Committee with PPN since its inception, spoke in recognition of the 10th anniversary of PPN's.

Jarlath reflected on the formation of PPN's as their current structure, and the pre-curser to the PPN which was the Community and Voluntary Forum, he also noted that Galway County PPN formally began in March 2004 when the Forum was dissolved. He spoke about the development of the national PPN Handbook as vital resource for all PPN's.

Dan spoke about the progress of the PPN, how vital the input from all stakeholders is both locally and county wide is, and the value of being involved with the PPN structure, for him and all who volunteer for PPN Representatives or Secretariat committee positions, as well as to all regular PPN member organisations. He mentioned the increase in funding to allow for a second PPN staff a number of years ago, and the 2025 increase in operational budget.

Vincent looked to the future of the PPN and recognised the significant milestone of the 10th anniversary while reflecting on his journey with the PPN. He spoke about the value of being involved with the national and regional PPN networks and working groups or advisory groups of the PPN national structure, as a Representative of Galway County PPN or of the Community and Voluntary Pillar, at different times over the years.

All three Secretariat commended the PPN staff past and present, the support from Galway County Council, especially the PPN Liaison past and present. The Department of Rural and Community

Development (DRCD) staff from the PPN national office were also thanked. It was noted that without the ongoing support of Galway County Council and the Department of Rural and Community Development, both financially and with other resources and supports, the PPN would not be in operation nor as successful as it is today.

Long Service Awards presentations - to Jarlath, Dan and Vincent, by Jacqueline Carroll.

Jacqueline Carroll, the Director of Services for the Rural & Community Development, Integration and Environment Departments, Galway County Council, presented Long Service Awards on behalf of Galway County Council to Jarlath Canney, Dan Dowling, and Vincent Lyons. As all three of them are coming to the end of the maximum allowable 10-year term as PPN Secretariat members.

Jacqueline and Mary McGann, the PPN Liaison and Administrative Officer in Galway County Council Community Section, conspired to include this last-minute addition to the agenda which was a complete surprise to the award recipients and guests. The awards honor the dedication of the three volunteers with the PPN and their other voluntary activities in their communities. The recipients were completely surprised and delighted to receive the awards which comprised a framed certificated and inscribed, hand carved wooden sculptures, depicting a traditional boat, a symbol of Galway. They were each presented their awards separately and Jacquiline commended them for their dedication and asked them questions to reflect on their time with PPN.

> Amendments to PPN Representatives Charter - Vincent Lyons, PPN Secretariat.

Amendments to PPN Constitution & PPN Representatives Charter – for ratification by Plenary. Amendments related to: PPN Reps sitting on the following committees:

Local Community Development Committee (LCDC), Strategic Policy Committee (SPC), and PPN Secretariat Committee.

The need for the amendments was identified by Galway County Council PPN Liaison and drafted with the PPN Resource Worker. The text was distributed to all Plenary attendees, and it was instructed that only PPN members organisations should vote.

The following amendments were approved by a majority show of hands at Plenary 19/11/2025.

LCDC & SPC's:

Remove:

The term of a representative on the JPC, LCDC and SPCs is 3 years in length. A representative can serve a maximum of two consecutive terms (six years in a row). A representative who has served two terms cannot serve a third consecutive term on the same committee. An outgoing representative can serve a further consecutive term only in the event of the linkage group not having a suitable replacement.

Replace with:

<u>Local Community Development Committee (LCDC):</u>

The initial term of a representative is 3 years and at the end of this period, it will be reviewed by the LCDC, and the term may be extended for no more than 3 more years. Following the



maximum term of 6 years, there must be a compulsory break of a minimum 3 years prior to any further nomination of that individual.

Strategic Policy Committees:

The term of a representative on the SPC's is 5 years in length, in line with the term of office of the Elected Council. A representative can serve a maximum of two consecutive terms. A representative who has served two terms cannot serve a third consecutive term on the same committee.

PPN Secretariat:

Remove:

The term of the Secretariat members is the length of the council term and 3 years thereafter. A Secretariat member can serve a maximum of two consecutive terms. A Secretariat member who has served two terms cannot serve a third consecutive term. An outgoing Secretariat member can serve a third time after first taking a one term break.

Replace with:

The term of a representative on the PPN Secretariat is 5 years, and a representative can serve a maximum of 2 consecutive terms. The Secretariat will ensure that the PPN Secretariat Membership is refreshed at least every 3 years, through naturally occurring vacancies and/or the longest-standing members stepping down.
